Pay attention to the trade of USD/JPY, Natural Gas, Silver, Wheat, Sugar, Coffee & Cocoa

Commodities:

- **Natural Gas** trend is UP till 1st half of 2nd January thereafter trend is Dual till 1st half of 5th January. trend is Down from 2nd half of 5th January to 19th January (strongly recommended)
- **Palladium** trend is UP from 2nd half of 2nd January to 5th January
- **Platinum** trend is UP till first half of 3rd January
- **Silver** trend is Down till 3rd January
- **Gold** trend is Dual with bearish bias till 5th January
- **Copper** trend is Dual with bullish bias on 1st January, trend is Up from 4th January to 1st half of 5th January
- **Wheat** trend is Down till 7th January (strongly recommended)
- **Sugar** trend is UP till 26th January with uncertainty on 4-5 & 15-16 January
- **Coffee** trend is Down till 7th January (strongly recommended)
- **Cocoa** trend is Down till 5th January

Currency

- **USD/JPY** trend is Up till 3rd January thereafter trend is Down till first few hours of 9th January (strongly recommended)
- **GBP/USD** trend is Dual till 3rd January thereafter trend is UP till 5th January
- **Euro/USD** trend is UP till 12th January with dual trend on 5th January (there will be sharp rise in euro/usd on 17th & 18th January)

Indices, Bonds & Stocks:

- **S&P** trend is Down till 1st half of 1st January thereafter trend is UP till 14th January
- **Sensex** trend is UP till 4th February with uncertainty on 5th, 15-17, 22nd January & possible down move on 10-12 January
